SISTER RUTH AGEE

A True Blessing to the QueensCare Organization

ong before electronic health records were created and before smart phone I health apps were developed, there were dedicated religious Sisters providing healthcare to Los Angeles' underserved and uninsured. That dedication and service continues today as QueensCare works to improve the health of Los Angeles communities and reduce health disparities. One such Sister has made a significant impact at QueensCare over her 15 years of service.

Sister Ruth Agee became a Franciscan Sister of the Sacred Heart in 1967 and had a career teaching elementary school students in Illinois and Indiana for 27 years. When she moved back to California in 2005, she wanted to shift careers but continue in the Sisters' ministry with a faithbased organization that makes a difference for those in need in the Los Angeles area.

In her role, essentially behind the scenes at the QueensCare administrative offices in downtown Los Angeles, Sister Ruth keeps things running smoothly and efficiently for Barbara Hines, President and CEO, in addition to performing a multitude of other tasks for others in the organization. These include everything from maintaining corporate documents and writing minutes and agendas, to coordinating important appointments and meetings.

Says Sister Ruth, "During the time I have been with QueensCare, I have seen much growth and many changes, but one thing remains constant. It is our unwavering commitment to the mission and values passed on to us by Mr. Joe Brandlin and Mr. Art Barron, which is helping and caring for those that need it most. I have great satisfaction knowing that the service I provide each day contributes to the work 'in the field' that has impacted so many lives in positive and meaningful ways."

Over the years, the kinds of changes Sister Ruth has seen include how technology

advances have vastly improved and streamlined our delivery of quality care for our patients. QueensCare Health Centers was one of the first healthcare organizations to adopt the use of electronic records and it continues to enhance the OCHIN EPIC™ platform, one of the most advanced electronic health record systems available.

Sister Ruth has also seen QueensCare become a leading voice in transforming the healthcare industry from a focus on acute sick care to a focus on preventative health and lifelong wellness. Programs that embrace new tools that include better nutrition, exercise and appropriate medicines to better manage health are helping Angelenos cultivate new habits for their health and wellness for many years to come. Overseen by the QueensCare Health & Faith Partnership (QHFP), a group very visible in the communities where they serve, these programs include ongoing medication management and reconciliation (ensuring that multiple medications often prescribed separately are safe to be taken together), along with blood pressure and glucose screens, so necessary to prevent, diagnose or manage life-threatening diseases.

Sister Ruth has also witnessed QueensCare adopt a more active role in providing continuing education for its staff. Because engaging providers, nurses, pharmacists and health advocates can lead to improved quality and better patient care, QueensCare has greatly increased its commitment to enhancing and advancing the skills and leadership of its staff. As QueensCare grows into the next generation of healthcare, Sister Ruth looks forward to continuing to be a part of caring for and serving those in the community who are most vulnerable and have the fewest resources. Says Sister Ruth, "QueensCare is not a static organization but is always looking for new tools and new ways to operate more effectively so we can help more people."

A Career Blossoms Through the Kindness of QueensCare

hree years ago, Amy Perez found herself in the emergency room of Hollywood Presbyterian Medical Center with her mother who was having severe stomach pain. The doctors found a serious infection with no option for surgery.

Amy spent seven days beside her Mom while her mother received treatment. Alone with her Mom, Amy felt isolated and overwhelmed. As Sister Mary Shin John was completing her morning rounds of visiting patients, she offered Amy comfort and encouragement. Sister Mary also gave Amy a bible to help her find the strength she needed to deal with her Mom's situation and Amy found great solace in Sister's warmth and compassion. Ultimately, Amy's mother recovered from the infection and was released from the hospital in time to return home for Christmas.

Amy learned that this was not the first time that QueensCare crossed paths with she and her mother. Years earlier when her Mom was pregnant with Amy, Mirelia Perez sought and received pre- and postnatal care from QueensCare when it was known as Queen of Angels-Hollywood Presbyterian Medical Center and it's where Amy was born.

Over the years, the bible that Sister Mary gifted to Amy has been a source of both inspiration and strength to her and it has carried her through both good and bad times. In 2018, Amy received a Masters Degree in Social Work from USC and her Mom was there to celebrate her great accomplishment.

Coming full circle, earlier this year Amy joined QueensCare's Mental Health Program, where she is helping support the next generation of QueensCare patients. As part of our mental health team, she is assisting children and families to cope with challenges and build resiliency. The team provides both individual and family therapy in a kid-friendly environment where young patients dealing with anxiety, trauma, depression and disruptive behavior can feel safe, secure and welcome.

Now an employee, Amy recently ran into the familiar, warm Sister Mary who greeted her with the same kindness and caring she had several years ago. As they reconnected, they were able to share a beautiful moment of reflection and healing.

Says Amy, "QueensCare has been part of my journey from childhood through adolescence, and now as I embark on my career as a mental health clinician. QueensCare's mission, vision and core values align closely with my own and I seek to bring the same spiritual compassion to my patients as Sister provided to my mother and me when we needed it most."







AREVALO FAMILY Whitening McQueen's Huge Impact on Our Community

ueensCare's very successful Mobile Dental Program (MDP) has experienced a real boost with the addition of its state-of-the-art Whitening McQueen dental trailer. This fiscal year, the nearly 1000 square foot dental trailer and a pair of our older trailers served seven schools, saw 1,240 patients, completed 4,703 appointments and conducted 9,839 dental procedures, valued at \$953,076, to the QueensCare community - free of charge. The program operates through a partnership with the Herman Ostrow School of Dentistry of USC and visits qualifying Primary and Secondary Service Area schools on a rotating basis.

In the summer, when school is out, Whitening McQueen visits key community locations such as Adventist Health White Memorial Medical Center in East Los Angeles. This partnership with White Memorial received notable news media coverage for the 'Wellness Rocks' event held at the opening of the summer program to spread the word to more children in East Los Angeles.

The family of Jazlyn Arevalo first learned about the QueensCare Mobile Dental Program when it visited Jazlyn's Betty Plasencia Elementary School campus in 2017. Jennyfer Arevalo had not had a good experience with her daughter's previous dentist, so she decided to make an appointment to have her daughter seen. When Whitening McQueen arrived on campus this year, the children were very excited to see their friendly USC dentists in this brand new facility.

According to Jennyfer, "Jazlyn used to be fearful of the dentist before coming to QueensCare. Her previous dentist was very rough with her and lacked patience with children, often making Jazlyn cry. Now that Jazlyn has had the necessary dental treatment from QueensCare, including the crown she needed, she is no longer afraid of the dentist and very happy with the crown she received."

Jazlyn describes her experience with both the dental assistants and dentists at QueensCare as great. "They were very patient with me, held my hand, took care of me and were very helpful," she says. "I trusted the QueensCare staff because they were nice to me. I was a little scared at first, but they were kind and patient and made me feel comfortable. My old dentist used to give me ugly silver fillings, and at QueensCare, I received fillings that are the same color as my teeth."

Jazlyn's positive experience with QueensCare's Mobile Dental Program carried over to other members of her family. Her mother, Jennyfer, met Dental Assistant Xochitl Janet Larios when her daughter was receiving treatment. At this time, because Jennyfer was complaining of a toothache, Xochitl recommended that she call QueensCare Health Centers' Echo Park location to make an appointment. Her infected molar ultimately had to be removed, but she continues to go to the Echo Park location and Jazlyn's grandmother receives dental services there, too.

Says Jennyfer, "The QueensCare dental programs are wonderful for the whole family and are truly a blessing to our community. We have recommended them to our friends and hope other families will benefit from these excellent programs."

JOAN AGNES FRITZ

Pidge's Gifts to Healthcare in Our Community

oan Agnes Fritz was born in Dublin, Ireland on February 8, 1932 to John and Bridget Pidgeon. She immigrated to the United States in 1958, at age 26, settled in Los Angeles and married Conrad Fritz in 1966.

Sadly, Joan passed away in August of 2018 at the age of 86. Her friends and family will always remember her vibrant, loving personality. She was passionately interested in civic life and politics, and rarely missed a day's news. She was very generous in her help of family members and political causes. In their words, "To know Joan was to love her."

Joan first crossed paths with the beginnings of QueensCare when she came to work in the law firm of Vaughan, Brandlin, Robinson & Romer in 1958 shortly after arriving in Los Angeles. One of her coworkers at that time, Kathryn Brandlin Shearer, has very fond memories of working with "Pidge", as she was known by family and friends.

"My first impression of Joan was she was the happiest person I'd ever met. She was only 15 years older than me and she and her sister, Mary, had traveled by boat to the U.S. from Ireland. After arriving in New York they drove across the country to Los Angeles to work for my father, J.J. Brandlin and Bob Vaughan in their downtown law firm. What amazing and courageous women!"

Joan was the receptionist in the office. She ran the PBX 555 switchboard, greeted clients, kept track of the attorneys' time, sent bills, and did a myriad of other organizational tasks. She was cheerful and happy all the time and set the tone for the entire office.

Calling her by her nickname, "Pidge" was a privilege that all the other staff and attorneys had. As the youngster in the office, I had to earn it by paying close attention to everything she taught me about operating the switchboard, addressing everyone politely and writing clear and correct notes for every call that came through that big switchboard. Finally, I earned the privilege! It was almost as good as getting a raise! "Pidge" was unflappable, funny, a great listener and always ready to help and advise.

Pidge's close and long-time friend, Evelyn Knapp also has very warm memories of her.

"Joan and her sister, Mary, were extremely proud to be Americans and voted in every election that came their way. They were extremely patriotic that way. Joan always said, as an immigrant, this country had been very good to her and that is the main reason she always gave back to people in need."

Following her husband's death, Pidge learned

she had colon cancer and that she needed surgery to remove the malignancy. She did this and never looked back. In 2014, I was with her when she learned she had breast cancer and needed a mastectomy. Two days after the surgery, we were at the Science Museum to see the Endeavor exhibit. Joan was very strong and didn't like to linger or feel sorry for herself or her situation.

With her passing in August of 2018, Pidge's legacy lives on in the form of a generous gift to QueensCare that will help provide accessible quality healthcare to underserved Los Angeles communities. She made sure that her legacy would continue to benefit others.

Joan Agnes Fritz made yearly donations to QueensCare beginning in 2007, in addition to her bequest this past year. Gifts like Joan's are a lifeline to those in need – free dental care for children whose parents can't afford it; free eye exams and glasses for students who cannot see the white-board; and healthcare and wellness screenings for adults grappling with diabetes and high blood pressure. Joan's support is greatly appreciated by all of us at QueensCare, by the thousands of individuals she has already helped, and by those she will help in the future.



2019 News and Updates

DIRECT HEALTHCARE DIVISION

The Mental Health Program

- Provided \$195,240 in mental health services to 53 children and their families under a contract with Children's Hospital Los Angeles.
- Acquired a full-time bilingual mental health clinician to better serve Spanish-speaking patients.
- Attended the Trauma Informed Care and Cultural Competence conferences to expand clinician knowledge of best practices and enhance skills

The Mobile Vision Program

- Visited 33 Los Angeles Unified School District (LAUSD) middle schools (a 6% increase from fiscal year 2018), providing screenings by contracted school nurses and eye exams by a QueensCare optometrist.
- Screened over 12,000 students, with the optometrist and optometry assistant examining 2,221 students and provided glasses to 1,106 children free of charge.

The Mobile Dental Program

- Served 7 schools; saw 1,240 patients; completed 4,703 appointments; and conducted 9,839 procedures.
- Provided services valued at \$958,076 to the community free of charge.
- Partnered with Adventist Health White Memorial to serve children in East Los Angeles, receiving notable news media coverage for the Wellness Rocks event held at the opening of the summer program.
- Received feature coverage for Whitening McQueen from KTLA 5's award winning reporter, Gayle Anderson.

The Inpatient Program

 Provided over \$2 million in inpatient services to uninsured patients through contracts with six hospitals: California Hospital Medical Center; Cedars-Sinai Medical Center; Glendale Memorial Hospital and Health Center; Good Samaritan Hospital; St. Vincent Medical Center; and
 Adventist Health White Memorial Medical Center.

Q/QHC Healthcare Partners

 Through this strategic partnership with QueensCare Health Centers, an independent 501©3 non-profit public charity and federally qualified health center, nearly 25,000 patients received primary adult and pediatric care, as well as dental, vision and podiatry care in over 100,000 visits during the year.

QueensCare Health & Faith Partnership (QHFP):

- Serviced 17 full affiliate sites including the Braille Institute and the Armenian Relief Society, food pantries, homeless shelters, churches, synagogues, and senior nutrition sites, conducting 7,004 patient visits.
- Planned and participated in 268 site events and attended 32 health events/health fairs, completed screenings for 6,078 patients.
 Health events feature nutrition classes, heart health, tuberculosis and osteoporosis testing, vision and blood pressure screening, body mass index (BMI) measurements, glucose monitoring, and first aid services.
- Acted as school nurse at several low income schools of The Roman Catholic Archdiocese of Los Angeles providing various health services.
 These include reviewing vaccination records for compliance, delivering health education classes, and screening for vision, hearing, and scoliosis.

PASTORAL CARE DIVISION:

- Furnished over 35,000 patients with spiritual comfort at CHA Hollywood Presbyterian Medical Center (HPMC).
- Anointed 849 individuals.
- Counseled 340 patients on advance healthcare directives, completing 27 such directives.
- Conducted daily mass for patients and staff at HPMC in collaboration with local parishes.

CHARITABLE DIVISION:

- Approved 43 grants totaling \$2,959,357.
- Awarded 28 scholarships totaling \$275,000 and two loan repayment award through the Gene & Marilyn Nuziard Scholarship and Loan Repayment Program, with recipient students representing 10 colleges and universities.
- Awarded \$2,002,000 to 15 local hospitals through the Emergency Medical Services Fund, which pays uninsured patients' fees for emergency room visits.
